2025 Vendor Contract: (please read and sign below)

- 1. Each exhibitor will be given a 10x10 space in the EXPO/FINISH LINE Area.
- 2. EXPO exhibitors will be responsible for providing ALL supplies needed (table, chair, electrical cords, etc.)
- 3. FINISH LINE exhibitor will be provided with one 8-foot table and two chairs.
- EXPO Exhibitors must be set up by 11:30AM, and must have their area torn down/cleaned up by 9:00PM.
 FINISH LINE Exhibitors must be set-up by 7:30AM, must have their area torn down/cleaned up by 12:30PM.
- 5. No refunds will be given to exhibitors who fail to occupy their space.
- 6. Exhibitor may not sublet their space unless given prior approval.
- 7. EXPO and FINISH LINE Exhibitors agree to be open and staffed during all event hours.
- 8. Exhibitors are responsible for their purchased space and property as well as the set-up/tear down of their space.
- 9. Exhibitors must promote within their designated space and stay clear of walkways and interference of other exhibitors.
